During your system's 16-point Annual Inspection and Safety Check, our technicians perform the following to ensure your generator is properly maintained and running at peak efficiency:

- Inspect fuel lines and connections
- Inspect flexible fuel lines
- Inspect oil level
- Replace oil
- Replace oil filter
- Inspect enclosure louvers
- Inspect for vibration, noise, leakage, temperature
- Inspect battery
- Remove corrosion
- Inspect and replace electrolyte level (if necessary)
- Inspect and replace air cleaner (if necessary)
- Inspect and replace spark plug(s) (if necessary)
- Apply corrosion inhibiting spray to engine
- Inspect electrical connection box
- Inspect entire electrical system
- Test operation

- 1. Quinoco is not responsible for the discovery or removal of asbestos or other hazardous materials.
- 2. It is the homeowner's responsibility to contact Quinoco at the time they receive or renew their Plan to set up the Annual Inspection and Safety Check appointment. Quinoco will not credit or prorate any Annual Inspection and Safety Check not conducted during the plan term.
- 3. Plans are for residential generators only.
- 4. Concealed or buried parts, pipes, and wiring are not covered.
- 5. This Plan does not cover parts or labor required as a result of Acts of God, fire damage, flooding, damage due to frozen pipes or water, fuel run-outs, and power failure. Quinoco will not be liable for care due to negligence by the owner or owner's agent from not properly checking an occupied or unoccupied property.
- 6. There shall be no liability for any reason on the part of Quinoco for work done by another party, unless such party is authorized in writing by Quinoco to perform such work.
- 7. Quinoco reserves the right to modify this Plan as to price or other terms and conditions effective on the anniversary date. The length of this Plan is one year and will automatically be renewed at that time unless we are notified of cancellation in writing 30 days prior.
- 8. This Plan does not cover the repair or replacement of obsolete parts that are not available from regular supply sources.
- 9. Work performed on non-covered parts will be billed at prevailing repair rates.
- 10. Quinoco reserves the right to inspect the generator for eligibility prior to issuing or renewing the Plan. Quinoco may void this Plan at any time due to age, location, or overall condition of the generator. Pre-existing parts failure and service issues are not covered by the plan.
- Quinoco will not be liable for any delay or failure to provide service due to conditions beyond its control such as Acts of God; labor disturbances or strikes; unavailability of mechanics or parts; failure or interruption of electricity; inaccessibility of the generator; severe weather conditions; or government laws or regulations.
- 12. The homeowner must provide safe and sanitary work areas to Quinoco employees.
- 13. Service is provided at regular rates Monday Friday 8am to 4:30pm. After hours service is available at overtime rates.
